2022/2023 Fee Schedule

REGISTRATION FEES are non-refundable and non-transferable and must be paid by cash, money order, or credit/debit card only. (Credit/Debit card payments are subject to a processing fee.)

Book and Administrative Fees must be paid in full by the assigned due dates for student registration to be considered complete.

K – 8th Grade Book Fees: \$320.00 DUE within 2 wks of registration*

K – 8th Grade Administrative Fees: \$160.00 DUE JULY 25

Preschool Book & Administrative Fees: DUE within 2 wks of registration*

*When enrolling after July 1, these fees are due at the time of registration.

Receive a \$30 account credit when paying K-8 Book and Administration Fees together before 5/9.

TUITION payments are due on the 1st of each month from August 1, 2022 to May 1, 2023 and are “late” if not received in the office by the 5th of the month regardless of the day this date occurs. A *Late Payment* fee of \$25.00 will be assessed to the account on the 6th of the month.

K – 5th Grades: \$5,750.00 Annual / \$575.00 Monthly

6th – 8th Grades: \$6,000.00 Annual / \$600.00 Monthly

PRE-SCHOOL TUITION payments are due on Monday of each week. Tuition is non-refundable and non-transferable. (A \$70.00 Maintenance Fee is applied if a student is not in attendance for the entire week.)

2-Year-Old Class:	245.00 (Weekly Payments)
3-Year-Old Class:	235.00 (Weekly Payments)
4-Year-Old Class:	225.00 (Weekly Payments)

*Tuition discounts are offered for multiple students (siblings) living in the same household. Members of Cornerstone Christian Center may be eligible for the Church Discount on tuition. Contact the Finance Office for additional information.

EXTENDED DAY CARE (EDC) CHARGES: \$225.00 per month full time (9+ days) or a daily rate of \$25 per student/per day of EDC for 1 to 8 days in the month. *Multiple child discounts are available only when paying full time monthly EDC charges.*

LATE PICK UP FEES: \$25.00 will be charged for each 15-minute increment (or fraction thereof) that a student remains in EDC after 5:00 p.m. according to Cornerstone’s clock system.

Cornerstone Christian School Financial Policies

1. Book Fees are within 2 weeks of registration unless otherwise noted. Administrative Fees are due by July 25, 2022.
2. K-8 Tuition payments are due on the 1st of each month beginning August 1, 2022. The final tuition payment, along with any outstanding balance, will be due May 1, 2023. **Please note that you are not paying for the number of school days per month: this is a payment plan** for those not paying the entire cost at the beginning of the school year. Tuition paid in full by September 1, 2022 will be reduced by \$100.00. Tuition paid in full by January 1, 2023 will be reduced by \$75.00.
3. Tuition payments received in the school office **after the 5th of the month, regardless of when this date occurs, are considered "late" and a \$25.00 Late Payment fee will be assessed to student accounts. Students may be held out of class until the balance has been paid in full.** If payments are late two (2) times within a school year, your child/children may be dropped from enrollment.
4. The first prepaid **Extended Day Care (EDC) payment is due with the AUGUST tuition payment** and the final payment with MAY tuition. Occasional use of EDC is billed one (1) month in arrears and must be paid in full by the 15th of the statement issued month, beginning with the September billing. **Unpaid balances after the 15th of each month may result in your child being held out of class.**
5. EDC Late Pick Up charges are \$25.00 for each 15-minute increment (or fraction thereof) that a student remains in Extended Day Care after 5:00 p.m. according to the Cornerstone school clock system.
6. The return of a check written to Cornerstone Christian School will result in a \$30.00 Returned Check Fee issued with each check returned for non-payment. After one (1) returned check, payments are to be made in cash, money order or by credit/debit card for the remainder of the school year. If the returned check was written for tuition prior to the 5th of the month and that amount is not settled by the 5th of the same month, the tuition is considered unpaid and the \$25.00 Late Payment Fee will be applied in addition to the Returned Check Fee. Postdated checks will not be accepted.
7. For your convenience we accept Visa, MasterCard, and Debit cards. There is a \$3.00 processing fee for credit/debit card transactions.
8. A 2 (two) week written notice must be given to the office to officially drop your child from enrollment. If you leave Cornerstone with an unpaid balance, you will be given 10 (ten) days to clear your account before it is sent to our collection agency. **For any month that your child is in attendance, regardless of the number of days, you are responsible for that month's entire payment.**
